Application:

The request to participate shall be drawn up in English using the form provided with the tender documentation.

The tender documents are to be submitted by email to: <u>koch@stiftung-evz.de</u> quoting reference "Bid in the call for competition for Commitment to the Survivors of NS Persecution in Poland."

The date and time at which the email is received at the above email address determine whether the deadline for submission of applications has been met. Requests to participate received after the deadline will not be considered. The bid must bear a signature. Applicants are required to exercise special care when preparing the documents.

Requests to participate can be withdrawn, either in writing (post) or by email, at any time up to the deadline for submission. After this date, the applicant is obliged to honour the request until the period of validity (of the application) expires.
